TRADEMARK AND DOMAIN NAME ASSIGNMENT

Assignor hereby transfers and assigns to Assignee, and Assignee hereby accepts the transfer and assignment of, (i) all of Assignor's rights, title, and interest in and to the Trademark and the Domain Name, together with the goodwill of the business connected with the use of and symbolized by the Trademark and the Domain Name to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors and assigns, and (ii) all rights of Assignor to bring an action, whether at law or in equity, against any third party for infringement or other misuse of the Trademark and Domain Name, including the right to bring an action for past, present, and future infringement, dilution, unfair competition, or other misappropriation or misuse, and all rights to recover damages, profits, attorneys' fees, and injunctive relief for infringement, dilution, unfair competition, or other misappropriation or misuse.
2. Representation. Assignor hereby represents and warrants that the information set forth herein is accurate and complete and that neither it nor, to its knowledge, any entity controlled by, controlling, or under common control with the Assignor own any other trademark applications, registrations, or domain names for the JAYSKI'S trademark other than those identified herein.
