**TERMINATION AND RELEASE OF SECURITY  
INTEREST IN INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination"), is dated as of May 15, 2019, and made by PRIDE FAMILY BRANDS, INC., a Florida corporation (the "Grantor"), and LBC CREDIT PARTNERS III, L.P. (the "Agent"), on behalf of itself and the other Secured Parties.

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of June 15, 2015, made by Grantor in favor of Agent (as it may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") and documents ancillary thereto, a continuing security interest in, a continuing lien upon, and a right to set off against was granted by the Grantor to Agent for the ratable benefit of the Secured Parties in certain collateral;

WHEREAS, a Patent security interest was recorded with the United States Patent and Trademark Office on June 17, 2015 at Reel 035941; Frame 0168 and supplemented on May 22, 2018 at Reel 045876; Frame 0581; and

WHEREAS, a Trademark security interest was recorded with the United States Patent and Trademark Office on June 17, 2015 at Reel 5555; Frame 0074 and supplemented on May 22, 2018 at Reel 6362; Frame 0438; and

WHEREAS, Agent now desires to terminate and release the security interest, lien and right to set off against the collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement (as defined below).

2. Release of Security Interest. Agent hereby terminates the Security Agreement and irrevocably terminates, cancels, releases and discharges the entirety of any and all liens, security interests or rights to set off against that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement and documents ancillary thereto, in the Grantor's intellectual property, including the patents and trademarks listed on Schedule A hereto, and reassigns, transfers and conveys to the applicable Grantor all right, title and interest of Agent in the intellectual property, and any right, title or interest of the Agent in such intellectual property shall hereby terminate, cease and become void. Agent authorizes the U.S. Patent and Trademark Office to modify its records to indicate the discharge of said security interests, liens and rights.
