**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "*Termination and Release*") is dated as of May 17, 2019 by **GOLD HILL CAPITAL 2008, LP** ("*Secured Party*"), in favor of **ROKU, INC.**, a Delaware corporation ("*Grantor*"), having its principal offices at 150 Winchester Circle, Los Gatos, CA 95032.

WHEREAS, pursuant to a Loan and Security Agreement dated as of July 13, 2011 by and between Grantor and Secured Party, Grantor executed and delivered (a) an Intellectual Property Security Agreement, dated as of July 13, 2011 (the "*IP Security Agreement#1*"), granting and pledging to the Secured Party a security interest in all of Grantor's right, title and interest in, to certain intellectual property, which was recorded with (i) the Patent division of the United States Patent and Trademark Office ("*USPTO*") on July 18, 2011 at Reel 026604, Frame 0852; and (ii) the Trademark division of the USPTO on July 18, 2011 at Reel 4584, Frame 0618, and (b) an Intellectual Property Security Agreement, dated as of April 27, 2012 (the "*IP Security Agreement#2*") and together with the IP Security Agreement#1, the "*IP Security Agreements*"), granting and pledging to Secured Party a security interest in all of Grantor's right, title and interest in, to certain intellectual property, which was recorded with the United States Copyright Office ("*USCO*") on May 9, 2012 at Volume 3605 Doc No. 937.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby:

1. terminates the IP Security Agreements and releases, terminates and discharges the liens on and security interests in Grantor's right, title and interest in, to and under the intellectual property as granted in the IP Security Agreements, including those copyrights and copyright applications, patents and patent applications, and trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO and USCO.

THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF CALIFORNIA (INCLUDING, WITHOUT LIMITATION, SECTION 5-1401 OF THE GENERAL OBLIGATIONS LAW) WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES.
