## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of May 21, 2019, and made by **SILICON VALLEY BANK** ("Administrative Agent"), to **LIVE AUCTIONEERS LLC**, a New York limited liability company (the, "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 3, 2014, made by the Grantor in favor of Administrative Agent ("Security Agreement"), a security interest was granted by the Grantor to Administrative Agent in certain collateral, including all of the Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademarks, including those Trademarks set forth on the attached Exhibit A hereto;

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on October 6, 2014 at Reel/Frame 5375/0418;

WHEREAS, Administrative Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Administrative Agent hereby states as follows:

1. Definitions. Capitalized terms used herein without definition are used as defined in the Security Agreement.

2. Release of Security Interest. Administrative Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Administrative Agent in the Trademarks.
