TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 22, 2019, by GOLUB CAPITAL MARKETS LLC (F/K/A GCI CAPITAL MARKETS LLC), as administrative agent (in such capacity, "Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Paper Source, Inc., an Illinois corporation ("Grantor"), and Secured Party are parties to that certain Trademark Security Agreement dated as of April 19, 2016 (the "Security Agreement") pursuant to which Grantor granted a security interest to Secured Party in certain Trademark Collateral (as defined therein) as security for certain obligations owing by Grantor to Secured Party, including the Trademark Collateral set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 14, 2016, at Reel 5813, Frame 0936;

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor's right, title and interest in and to the following:

(i) each Trademark registration and Trademark application owned by Grantor, set forth on Schedule 1 annexed hereto;

(ii) all goodwill of the business associated with the use of, and symbolized by, each such Trademark; and

(iii) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future infringement, misappropriation, dilution, violation or impairment of any Trademark registration referred to in Schedule 1 annexed hereto, and the Trademark registrations issued with respect to the Trademark applications referred to in Schedule 1 annexed hereto.

2. Secured Party hereby releases its security interest in the Trademark Collateral and reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in and to the Trademark Collateral.
