## TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this “*Termination and Release*”) is granted as of May 23, 2019 by **Credit Suisse AG, Cayman Islands Branch, as Agent** (the “*Agent*”), in favor of **Greektown Casino, L.L.C.**, a Michigan Limited Liability Company (the “*Pledgor*”).

**WHEREAS**, pursuant to the Collateral Agreement dated as of April 25, 2017, (as amended, restated, supplemented or otherwise modified from time to time, the “*Collateral Agreement*”), among the Pledgor and the Agent, the Pledgor executed and delivered to the Agent an Intellectual Property Security Agreement dated as of April 25, 2017 (the “*IP Security Agreement*”), granting the Agent a security interest in and lien on the IP Collateral (as defined in the IP Security Agreement);

**WHEREAS**, the IP Security Agreement was recorded with the United States Patent and Trademark Office (“*USPTO*”) on April 25, 2017, at Reel 042330, Frame 0858 and Reel 6041, Frame 0854;

**WHEREAS**, the Pledgor has requested that the Agent terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Pledgor in, to and under all of the IP Collateral, including the patents and trademarks as fully described on the attached Schedule I as herein provided; and

**WHEREAS**, the Pledgor has requested that the Agent provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the IP Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby states as follows:

1. **Release of Security Interest.** The Agent hereby terminates the IP Security Agreement and releases, terminates and discharges all liens and security interests in the Pledgor's right, title and interest in, to and under the IP Collateral, including the patents and trademarks set forth in Schedule I, and all goodwill associated therewith.

2. **Recordation.** The Agent authorizes and requests that this Termination and Release be recorded at the USPTO by the Pledgor.

3. **Further Assurances.** Agent agrees to take all further actions, and provide to the Pledgor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, in each case, at the Pledgor's expense, as the Pledgor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Termination and Release.

4. **Governing Law**. This Termination and Release and the rights and obligations of the parties under this Termination and Release shall be construed in accordance with and governed by the law of the State of New York, except with respect to gaming laws, in which case Michigan law shall apply, without regard to any principle of law that could require the application of any other law.
