Assignor represents and warrants that Assignor is lawful owner of the entire right, title and interest to said marks and IP and said Goodwill associated therewith, and that the same are unencumbered, and is the holder of record title to the Applications and Registrations and IP, that Assignor has full power to make this assignment and related document with respect to the marks, the Goodwill, and the Applications and Registrations and IP as Assignee shall reasonably request to effect the intent of this Assignment.
