TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the “Assignment”) is made and entered into as of August 1, 2018 (the “Effective Date”), by and between Gotee Records, Inc., a Tennessee corporation (“Assignor”), and Gotee Media, LLC, a Wyoming limited liability company (“Assignee”), pursuant to that certain Asset Purchase Agreement by and between Assignor and Assignee of even date herewith (the “Agreement”).

WHEREAS, Assignor is the owner of those certain trademarks and service marks set forth on Exhibit A, attached hereto and incorporated herein by reference (the “Marks”), along with the goodwill associated with the Marks and the federal trademark registrations respecting the Marks; and

WHEREAS, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of Assignor’s worldwide rights, title, and interests in, to, and under the Marks, including the goodwill associated with the Marks and the federal trademark registrations respecting the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor does hereby sell, assign, transfer, set over, and convey to Assignee, and Assignee hereby accepts the transfer and assignment of, all of Assignor’s rights, title, and interests throughout the world in and to the Marks, including, but not limited to, the following:

- (a) the U.S. Trademark Registrations for the Marks as described on Exhibit A;
- (b) the goodwill connected with, pertaining to, and symbolized by the Marks;
- (c) all rights to sue for infringement of the Marks, whether arising prior to or subsequent to the Effective Date of this Assignment; and
- (d) and any renewals and extensions of all of the foregoing rights, title, and interests in and to the Marks that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada, and any other country or jurisdiction.

2. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment will be governed by and construed in accordance with the laws of the State of Wyoming without giving effect to its conflict of laws principles.

3. This Assignment will bind and inure to the benefit of the parties’ respective successors and assigns.

4. Assignor hereby agrees that Assignee has the right to record this Assignment.

5. This Agreement may be executed in counterparts, either manually or by so-called “electronic signature,” both of which will be deemed an original, and all such counterparts, together, will constitute one and the same instrument.

IN WITNESS WHEREOF, Assignor and Assignee, intending to be legally-bound hereby, have executed this Assignment as of the Effective Date.


