RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST dated as of May 28, 2019 (this “**IP Security Release**”), by JPMORGAN CHASE BANK, N.A. (the “**Collateral Agent**”) in favor of Anvil International, LLC, a Delaware limited liability company (the “**Grantor**”). Reference is made to (a) that certain Pledge and Security Agreement dated as of August 1, 2017 (as amended, modified, restated or supplemented from time to time, the “**August 2017 Security Agreement**”) among the Grantor, the other Grantors (as defined therein) from time to time party thereto and the Collateral Agent; (b) that certain Notice of Grant of Security Interest in Patents dated as of August 1, 2017 (the “**August 2017 Patent Security Agreement**”) between the Grantor and the Collateral Agent, (c) that certain Notice of Grant of Security Interest in Trademarks dated as of August 1, 2017 (the “**August 2017 Trademark Security Agreement**”) between the Grantor and the Collateral Agent, (d) that certain Pledge and Security Agreement dated as of October 31, 2017 (as amended, modified, restated or supplemented from time to time, the “**October 2017 Security Agreement**”) among the Grantor, the other Grantors (as defined therein) from time to time party thereto and the Collateral Agent, (e) that certain Notice of Grant of Security Interest in Patents dated as of October 31, 2017 (the “**October 2017 Patent Security Agreement**”) between the Grantor and the Collateral Agent and (f) that certain Notice of Grant of Security Interest in Trademarks dated as of October 31, 2017 (the “**October 2017 Trademark Security Agreement**”) between the Grantor and the Collateral Agent (together with the August 2017 Security Agreement, the August 2017 Patent Security Agreement, the August 2017 Trademark Security Agreement, the October 2017 Security Agreement, the October 2017 Patent Security Agreement and the October 2017 Trademark Security Agreement, the “**Security Documents**”).

WHEREAS, pursuant to the terms and conditions of the Security Documents, the Grantor granted to the Collateral Agent a security interest in and to all of the Grantor’s right, title and interest in, to and under any and all of the following (collectively, the “**Released IP Collateral**”):

- (a) the patents and patent applications set forth on Schedule A hereto (the “**Patents**”);
- (b) the trademark and service mark registrations and applications set forth on Schedule B hereto (the “**Trademarks**”); and

WHEREAS, the security interest in the Released IP Collateral was recorded with the United States Patent and Trademark Office on August 1, 2017 at Reel/Frame No. 43402/872, on August 1, 2017 at Reel/Frame No. 6120/432, on October 31, 2017 at Reel/Frame No. 44342/847 and on October 31, 2017 at Reel/Frame No. 6193/969.

WHEREAS, the Collateral Agent now desires to execute and deliver this IP Security Release to evidence the release of its lien on and security interest in and to the Released IP Collateral identified in Schedules A and B attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent and the Grantor hereby agree as follows:

SECTION 1. Release of Security Interest. The Collateral Agent does hereby release and convey to the Grantor, without recourse, representation or warranty of any kind, all of the Collateral Agent's right, title and interest in and to the Grantor's right, title and interest in and to the Released IP Collateral identified in Schedules A and B attached hereto.


SECTION 2. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
