**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS RELEASE dated as of May 28, 2019 (this “Release”) is made by Madison Capital Funding LLC, acting in its capacity as collateral agent (in such capacity, the “Collateral Agent”) under that certain Intellectual Property Security Agreement, dated as of August 16, 2018 (as amended, supplemented or modified and in effect from time to time, the “IP Security Agreement”) between Flo-Rite Products Company LLC (the “Grantor”) and the Collateral Agent.

WHEREAS, pursuant to the IP Security Agreement which was recorded on August 16, 2018 at Reel/Frame 6415/0837, the Grantor granted to the Collateral Agent a continuing security interest in all of Grantor's right, title and interest in, to and under the Intellectual Property Collateral (as defined in the IP Security Agreement and for purposes of this release, the “Released Collateral”), which includes those trademark registrations and applications set forth on the attached Schedule A;


WHEREAS, the Grantor has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate all of the liens and security interest created under the IP Security Agreement in the Released Collateral, (b) release all of its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.
