RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of May 17, 2019, by COMERICA BANK, a Texas banking association ("Lender") in favor of STRATUS AUDIO, INC., a Florida corporation ("Audio") and STRATUS VIDEO, LLC, a Delaware limited liability company ("Audio," and together with Video, collectively, the "Company"), each with its principal place of business located at 33 N. Garden Avenue, Clearwater, FL 33755. Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreements (as defined below), as applicable.

Recitals

WHEREAS, pursuant to the Loan and Security Agreement by and between Company and Lender, dated as of July 6, 2015 (as the same may be amended, modified or supplemented from time to time, the "Loan Agreement"), Company granted to Lender a security interest in the Intellectual Property Collateral, including the copyrights, patents and trademarks described on Exhibits A, B and C attached hereto, respectively under (i) an Intellectual Property Security Agreement, dated as of July 6, 2015 (the "2015 Security Agreement"), (ii) an Intellectual Property Security Agreement, dated as of March 11, 2016 (the "2016 Security Agreement"), and (iii) an Amended and Restated Intellectual Property Security Agreement, dated as of June 14, 2018 (collectively with the 2015 Security Agreement and the 2016 Security Agreement the "Security Agreements"), and such Security Agreements were recorded with the US Library of Congress Copyright Office and the US Patent and Trademark Office (on March 28, 2017 at Reel and Frame Number 041771/0597, on March 29, 2016 at Reel and Frame Number 5760/0357, on March 28, 2017 at Reel and Frame Number 6021/0026, and on June 18, 2018 at Reel and Frame Number 6356/0521) as set forth on Exhibits A, B and C.


