Second Lien Release of Security Interest in Trademarks

This Second Lien Release of Security Interest in Trademarks, dated as of May 30, 2019 (the "Release"), is made by ROYAL BANK OF CANADA, as collateral agent (in such capacity, the "Agent") in favor of AUTODATA, INC., a Delaware corporation, and AUTODATA SOLUTIONS, INC., a Delaware corporation (each a "Grantor" and collectively the "Grantors"). Capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below) or Trademark Security Agreement (as defined below), as applicable.

WHEREAS, Grantors entered into (i) that certain Second Lien Security Agreement, dated as of December 14, 2017 in favor of Agent (as amended, restated, or modified from time to time, the "Security Agreement") and (ii) that certain related second lien Grant of Security Interest in Trademark Rights, dated as of December 14, 2017 in favor of Agent (as amended, restated, or modified from time to time, the "Trademark Security Agreement"), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 17, 2017 at Reel 6230 Frame 0809;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantors granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantors' right, title and interest in, to and under the Trademarks that are not Excluded Property (including, without limitation, those items listed on Schedule I hereto), including the goodwill associated with such Trademarks and the right to receive all Proceeds therefrom (collectively, the "Collateral");

WHEREAS, the Grantors desire Agent to release, discharge, terminate and cancel its lien on and security interest in the Collateral of the Grantors, including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, without any representation, warranty, or recourse of any kind or nature, does hereby release, discharge, terminate and cancel its lien on and security interest in all of Grantors' right, title and interest in and to the Collateral, including any and all goodwill relating to the same, and assigns, transfers and conveys to each Grantor, in each case as applicable, any and all of its rights, title and interests in the Collateral of such Grantor.


The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
