RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of May 1, 2019 ("Effective Date") by Deutsche Bank Trust Company Americas, as Collateral Agent (the "Agent") in favor of AMFM Broadcasting, Inc., AMFM Broadcasting Licenses, LLC, AMFM Operating Inc., AMFM Radio Licenses, LLC, AMFM Texas, LLC, AMFM Texas Licenses, LLC, Capstar Radio Operating Company, Capstar TX, LLC, and AMFM Texas Broadcasting, LP (collectively, the "Grantors").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement among the Grantors and the Agent dated October 25, 2012 (the "Trademark Security Agreement"), the Grantors granted to the Agent a security interest in and to all right, title and interest in or to the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations and applications set forth in Schedule I attached hereto;

WHEREAS, the Grantors and the Agent entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Principal Properties Security Agreement dated as of October 25, 2012 among certain subsidiaries of Clear Channel Communications, Inc. and the Agent (the "Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 8, 2012 at Reel/Frame 4896/0341; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.
2. Release. The Agent, without representation or warranty of any kind, on behalf of itself and the Secured Parties, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth on Schedule I attached hereto, arising under the Security Agreement and the Trademark Security Agreement. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreement, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.


