## TRADEMARK ASSIGNMENT

that the Assignor shall be legally bound upon request from Assignees to execute all instruments properly which Assignees may deem necessary or desirable for securing and maintaining the Trademark hereby assigned, all without further compensation to Assignor.

The undersigned warrants that the rights and property herein conveyed are free and clear of any encumbrance.
