RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS (this "Release") is made as of May 28, 2019, ("Effective Date") by SOLAR CAPITAL LTD, in its capacity as Agent for the Lenders ("Grantee"), in favor of MITRALIGN, INC. ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Assignment of Intellectual Property Security Agreement, dated May 12, 2016 ("Assignment Agreement"), Healthcare Financial Solutions, LLC ("Retiring Agent") assigned, transferred and conveyed to Grantee, all of its rights, title and interest in and to certain intellectual property security agreements between Grantor and Retiring Agent;

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office with respect to trademarks on May 16, 2016 at Reel 005793, Frame 0744 and with respect to patents on May 24, 2016, at Reel 038806, Frame 0390;

WHEREAS, pursuant to the terms and conditions of that certain payoff letter dated as of February 12, 2018, by and among Grantee and Grantor, Grantee has consented to the release of the Lien on the Subject IP, including without limitation, all intellectual property collateral listed on EXHIBIT A attached hereto; and

WHEREAS, Grantee desires to release its Lien in the Subject IP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee's Lien in the Subject IP granted pursuant to the Assignment Agreement is hereby terminated and released.
2. To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantor, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Subject IP. Such assignment, transfer


and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantor.

4. Capitalized terms used but not otherwise defined herein shall have the meanings given to such terms in the Assignment Agreement.
