ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY (this "Assignment") is entered into on October 19, 2018 by Bellahousewares.com Inc. (f/k/a 8610070 Canada Inc.), a corporation organized under the Canada Business Corporations Act ("Bellahousewares"), Sensio Inc., a limited company organized under the Companies Act of Nova Scotia ("Sensio Inc."), 8479950 Canada Inc., a corporation organized under the Canada Business Corporations Act ("8479950" and collectively with Bellahousewares and Sensio Inc., the "Assignors"), and Sensio Inc., a corporation organized under the laws of the State of Delaware (the "Assignee").

WHEREAS, this Assignment is made pursuant to the terms of the Amended and Restated Agreement (the "Agreement"), effective as of June 10, 2018, by and among Star Elite Inc., Lavy Holdings Corp., Danny Lavy, Sensio Company, the Assignors, Hong and Co., the Assignee and Shae Hong (with each capitalized term used but not defined in this Assignment shall have the meaning ascribed to it in the Agreement); and

WHEREAS, pursuant to the terms of the Agreement, the Assignors have agreed to assign to the Assignee all of the Assignors' rights, titles and interests in the Intellectual Property included in the Purchased Assets listed on Exhibit A attached hereto (the "Intellectual Property").

NOW, THEREFORE, pursuant to the Agreement and in consideration of the mutual promises therein and herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties to this Assignment agree as follows:

1. Assignment. The Assignors hereby assign to the Assignee all of the Assignors' worldwide rights, titles and interests in any Intellectual Property, together with the goodwill associated therewith, all rights to sue for any infringement thereof (whether arising before or after the date hereof), and any original, provisional, non-provisional, divisional, continuation, renewal, substitute, reissue and re-examination applications and patents applied for or granted therefore in the United States, Canada and all other countries, including all rights of priority from the filing of said applications. The U.S. Patents and Trademarks Office and all other patent or trademark offices around the world where the Intellectual Property are filed are hereby authorized and requested to issue all patents and trademarks on the Intellectual Property or resulting therefrom to Assignee as assignee of the entire interest therein.
2. Further Assurances. At any time or from time to time upon the request of the Assignee, the Assignors shall execute additional documents and instruments, and shall do additional acts and things as the Assignee may reasonably request in order to fully effectuate the purposes of this Assignment.
3. Assignment Subject to Agreement. The Assignors and the Assignee acknowledge and agree that nothing in this Assignment shall be deemed to supersede, enlarge or modify in any manner whatsoever any of the provisions of the Agreement, including without limitation any representations, warranties, covenants, agreements and indemnities, all of which survive the execution and delivery of this Assignment and remain in full force and effect as provided in, and subject to the provisions of, the Agreement. If any conflict or

inconsistency exists between the terms of this Assignment and the terms of the Agreement, the terms of the Agreement shall govern and control.

4. Benefit. This Assignment shall bind and inure to the benefit of the Assignors and the Assignee and their respective successors and assigns.
5. Arbitration. From and after the Closing, any claim, dispute, or controversy of whatever nature arising out of or relating to this Assignment, including any action or claim based on tort, contract, or statute (including any claims of breach), or concerning the interpretation, effect, termination, validity, performance and/or breach of this Assignment shall be resolved by final and binding arbitration administered by an arbitrator to be mutually agreed by the Assignors and the Assignee or, if the Assignors and the Assignee are unable to agree on the identity of the arbitrator within fifteen (15) days, any party shall have the right to request that any court sitting in the Province of Quebec, district of Montreal, shall select and appoint such arbitrator and this Assignment shall be construed, interpreted, enforced and governed by and under the laws of the Province of Quebec without regard to its choice of law rules.
6. Counterparts. This Assignment may be executed in counterparts, each of which shall be considered one and the same agreement and shall become effective when counterparts have been signed by each party and delivered to the other party.
