**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
PATENTS, TRADEMARKS AND COPYRIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS, TRADEMARKS AND COPYRIGHTS**, dated as of May 31, 2019 ("Release"), is made by **ESCALATE CAPITAL PARTNERS SBIC III, LP**, a Delaware limited partnership ("Lender"), in favor of **CLOUDABILITY INC.**, a Delaware corporation (the "Pledgor").

**WHEREAS**, pursuant to (i) Loan and Security Agreement dated as of February 12, 2018 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Loan Agreement") by and between Lender and Pledgor and (ii) that certain Intellectual Property Security Agreement dated as of February 12, 2018 by and between Pledgor and Lender (the "IP Agreement") and recorded with the U.S. Patent and Trademark Office at Reel/Frame Nos. 6271/0930 and 44909/0690 (with a corrective filing at Reel/Frame No. 45347/0237), Pledgor granted and conveyed to Lender a security interest in the entire right, title and interest of Pledgor in and to all of Pledgor's Patents, Trademarks and Copyrights;

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender agrees as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement or IP Agreement, as applicable.

**SECTION 2. Termination and Release.** Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the entire right, title, and interest of Pledgor in and to all of Pledgor's Patents, Trademarks and Copyrights, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Loan Agreement and the IP Agreement; and

(b) authorizes the recordation of this Release with the USPTO and the Copyright Office, as applicable, at Pledgor's expense.


**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of California, without regard to its conflict of laws principles.
