CONSENT AGREEMENT

This Consent Agreement is made as of March 22, 2019 (the "*Effective Date*") by and between **Fabricut, Inc.**, an Oklahoma corporation having an address at 9303 E. 46th St., Tulsa, OK 74145 ("*Fabricut*") and **House of Harris, LLC**, a North Carolina limited liability company having an address at 5101 Dunlea Court, Suite 106, Wilmington, North Carolina 28405 ("*HOH*"). HOH and Fabricut are sometimes individually referred to in this Consent Agreement as a "Party" and collectively as the "Parties."

WHEREAS, HOH applied to register the mark HOUSE OF HARRIS (the "*Mark*") with the United States Patent and Trademark Office, as set forth in Application Serial No. 87/704,858;

WHEREAS, Fabricut opposed registration of the Mark, in Opposition No. 91243815; and

WHEREAS, the Parties wish to avoid the expense and uncertainty of continued litigation and have entered into a settlement agreement.

NOW, THEREFORE, in consideration of the premises and the mutual promises hereafter made, and in consideration of the representations, warranties and covenants contained in this Consent Agreement and the settlement agreement, the Parties agree as follows:

1. HOH has agreed for the benefit of Fabricut and its affiliates, successors, assignees and anyone else claiming on behalf of or through Fabricut, to certain limitations as set forth in the settlement agreement, on HOH's use of the Mark (the "*Limitations*");
2. The Limitations are also binding on HOH's affiliates, successors, licensees, assignees, and anyone else claiming on behalf of or through HOH or its affiliates, successors, licensees or assignees.
3. This Consent Agreement shall be subject to, and interpreted by and in accordance with, the laws (excluding conflict of law provisions) of the State of Oklahoma, with the courts of the State of Oklahoma in Tulsa, Oklahoma or United States District Court in Tulsa, Oklahoma as the sole jurisdiction and venue for any actions relating to the subject matter of this Consent Agreement. All parties consent to the jurisdiction of such courts and agree that process may be served in the matter allowed for by the law of the State of Oklahoma or United States federal law.
4. In the event of a conflict between the provisions of this Consent Agreement and the settlement agreement, the terms of the settlement agreement shall prevail.


