TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment is made effective as of September 19, 2017, by and between Parman Enterprises LLC, a Delaware limited liability company, formerly known as Stewart & Stevenson LLC, ("Assignor"), and Stewart & Stevenson LLC, a Delaware limited liability company, formerly known as Kirby S&S LLC ("Assignee").

WHEREAS,

1. On September 13, 2017 pursuant to a Purchase and Sale Agreement dated as of June 13, 2017 (the "Agreement"), Assignor, then in its capacity as Stewart & Stevenson LLC, executed a Trademark Assignment assigning numerous trademarks identified on Schedule A of the Trademark Assignment to Assignee, then in its capacity as Kirby S&S LLC;

2. U.S. Reg. No. 1,704,804 dated August 4, 1992 for the mark RAIL KING (the "Mark") was supposed to be included on Schedule A to the Trademark Assignment but the Mark was inadvertently left off Schedule A;

3. On September 14, 2017 Assignor changed its name from Stewart & Stevenson LLC to Parman Enterprises LLC;

4. On September 15, 2017 Assignee changed its name from Kirby S&S LLC to Stewart & Stevenson LLC; and

5. Assignor and Assignee, having recently become aware that the Mark was inadvertently left off Schedule A to the Trademark Assignment, would like to assign the Mark to Assignee with effect from September 19, 2017.

NOW, THEREFORE, subject to the terms of the Agreement and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged,

1. Assignor hereby irrevocably assigns, conveys, transfers and delivers to Assignee, nunc pro tunc, effective as of September 19, 2017, all right, title and interest in and to the Mark, including all common law rights to the Mark, together with all the goodwill of the business symbolized by the Mark and the registration thereon, and any and all income, royalties, damages,


and payments now or thereafter due and/or payable with respect thereto, and the right to sue, recover and retain damages, profits, costs and attorneys' fees for any past, present, and future infringement or other violations of the Mark.

2. Assignor agrees that it shall execute all further documentation as may be required to perfect Assignee's title in and to the Mark and to record this Trademark Assignment Agreement in the United States Patent and Trademark Office.
