**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of May 29, 2019 (this “Release”) is made by Madison Capital Funding LLC, acting in its capacity as agent (in such capacity, the “Agent”) under that certain Trademark Security Agreement, dated as of September 26, 2014 (the “Trademark Security Agreement”) by and between JTM Foods LLC (the “Grantor”) and the Agent.


WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on September 29, 2014 at reel 5370, frame 0301, the Grantor granted to the Agent a continuing security interest in all of Grantor’s right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement), including those trademark and service mark registrations and applications set forth on Schedule 1 attached hereto; and

WHEREAS, the Grantor has requested and Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.



NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Trademark Collateral.
