RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (the "Release") is made on this 30th day of May, 2019 by FirstBank, a Tennessee banking corporation (the "Secured Party").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 29, 2017 (the "TSA"), by and between the Secured Party and Pace Payment Systems, Inc., a Delaware corporation ("Grantor"), Grantor granted to the Secured Party a security interest in certain Trademark Collateral (as defined therein). Capitalized terms used herein but not otherwise defined shall have the meaning given such terms in the TSA;

WHEREAS, the security interest granted to the Secured Party under the TSA was recorded at the United States Patent and Trademark Office on January 5, 2018, at Reel 6258 and Frame 0181; and
