RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 31st day of May, 2019, by M&T BANK, a New York banking corporation ("Secured Party"), in favor of LSC ENVIRONMENTAL PRODUCTS, LLC, a Delaware limited liability company and TERRA NOVO, LLC, a Delaware limited liability company (collectively, the "Companies" and each individually, a "Company"). All capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such term in that certain Restated and Extension of Trademark, Patent, & Intellectual Property Security Agreement, dated as of August 7, 2018, executed by the Companies in favor of Secured Party and recorded with the United States Patent and Trademark Office on August 15, 2018 at Reel/Frame 6413/0709.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Secured Party hereby releases all liens and security interests granted by each Company in favor of Secured Party in all of such Company's right, title and interest in, to and under, arising out of, or associated with (including but not limited to contract rights, distribution rights, licensing rights, foreign rights, goodwill of the business, proceeds and income, receivables, and the right to sue for any claim by any Company against third parties for past, present, future infringement, dilution, breach of a license, or injury to the good will described below), the following, whether owned or existing at the time of the Security Agreement or thereafter created, acquired or arising:

(i) all trademarks, trademark applications, trademark licenses, names, brand names, company names, fictitious names, trade names, product names, slogans, and all designs related thereto and all other corresponding rights, whether the same are domestic, international, or foreign, throughout the world, without limitation and not limited to, each trademark, trademark application, and trademark license referred to on Schedule A attached hereto;

(ii) all the foregoing together with any and all continuations, continuations-in-part, divisions, extensions, modifications, provisionals, reissues, renewals, or substitutions thereof, as applicable;


(iii) the goodwill of the business connected with the use of and symbolized by any of the foregoing trademarks, and all moral and economic rights of inventors, or any similar or equivalent rights to any of the foregoing or other intangible asset throughout the world; and

(iv) all products and proceeds of the foregoing, including any claim by any Company against third parties for past, present, or future (a) infringement, dilution, or breach with respect to any trademark, or a related application or license.
