This TERMINATION OF PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of June 3, 2019, is made by and among Bank of America, N.A., as administrative agent and lender, as successor in interest to LaSalle Bank National Association ("Secured Party"), in favor of ADS Security, a Pennsylvania limited partnership, and Security Services of Murfreesboro Inc., a Tennessee corporation (collectively, the "Grantor"), as follows:



NOW, THEREFORE, the Secured Party, at the Grantor's sole cost and expense, hereby terminates, cancels and releases its Lien on and continuing security interest in and to the Patents, Trademarks and Copyrights, and all of the goodwill of the business connected with the use of, and symbolized by the Patents, Trademarks and Copyrights, and any and all right, title and interest of the Secured Party in the Patents, Trademarks and Copyrights shall hereby terminate, cease and become void.
