RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (“Release”), effective as of May 29, 2019, given by JPMORGAN CHASE BANK, N.A., a national banking association, with an address at 10 S. Dearborn, 7th Floor, Chicago, IL 60603, as Administrative Agent (“Agent”) to XOJet Sales LLC, a Delaware limited liability company (“Grantor”), as follows:

WITNESSETH

WHEREAS, the Grantor executed that Guarantee and Collateral Agreement, dated as of December 6, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) and granted to the Agent a security interest in the United States trademark registrations and applications set forth on Schedule A attached hereto (the “Trademarks”) to secure the Secured Obligations (as defined in the Security Agreement);

WHEREAS, in furtherance of the Security Agreement, the Grantor executed a Trademark Security Agreement, dated December 6, 2018 (the “Trademark Security Agreement”), which was recorded by the U.S. Patent and Trademark Office on December 7, 2018, at Reel 6545 and Frame 0866;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to terminate the encumbrance created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, without recourse or warranty, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Trademarks created by the Trademark Security Agreement and the Security Agreement and reassigns all right, title and interest it has in the Trademarks to the Grantor. No security interest is being released other than in respect of the Trademarks set forth in Schedule A hereto.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTOR’S AND THE ADMINISTRATIVE AGENT’S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
