RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of June 3, 2019, is made by **FIFTH THIRD BANK**, an Ohio banking corporation (for itself and as agent for each affiliate of Fifth Third Bancorp, collectively, "Secured Party"), and is as follows:

WHEREAS, **UNITED RETIREMENT PLAN CONSULTANTS, INC.**, a Florida corporation ("Debtor"), formerly known as NATIONAL INVESTMENT MANAGERS INC., and Secured Party are parties to that certain Trademark Security Agreement, dated as of March 21, 2011 (the "Agreement"), which was recorded with The United States Patent and Trademark Office on May 24, 2011 in its records at Reel 004546, Frame 0509; capitalized terms used but not defined herein will have the meaning given to them in the Agreement;

WHEREAS, the Agreement granted to the Secured Party a security interest in all of Debtor's right, title and interest in and to all of its Trademark Collateral, including, without limitation: (a) all of Debtor's right, title and interest in and to all of its now or in the future owned or existing Trademarks, including the Trademarks listed on Schedule I attached hereto and made a part hereof; (b) all renewals of each of the Trademarks; (c) all income, royalties, damages and payments now and in the future due or payable under or with respect to any and all of the Trademarks, including damages and payments for past or future infringements of any and all of the Trademarks; (d) all rights to sue for past, present and future infringements of any and all of the Trademarks; (e) all rights corresponding to each of the Trademarks throughout the world; (f) all rights of Debtor as licensor or licensee under, and with respect to, trademarks, service marks, trade names, and trademark and service mark registrations and applications, including the Trademark Licenses; and (g) together in each case with the goodwill of Debtor's business connected with the use of, and symbolized by, the foregoing; and

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates (i) its security interest and other rights in, to and under the Trademark Collateral and (ii) any and all other rights it may have under the Agreement.
