

**RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY**

This Release of Security Interests in Intellectual Property is made as of the 6th day of December, 2018, in favor of Peerless Network, Inc., a Delaware corporation, and its Subsidiaries identified in Schedule A (collectively, "Borrowers"), by Escalate Capital Partners SBIC III, LP, a Delaware limited partnership ("Lender").

WHEREAS, an Intellectual Property Security Agreement, dated June 18, 2015, made by the Borrowers in favor of the Lender was (i) recorded on June 24, 2015 by the Patent Assignment Division of the U.S. Patent and Trademark Office, at Reel/Frame 035964/0614 and (ii) recorded on June 24, 2015 by the Trademark Assignment Division of the U.S. Patent and Trademark Office, at Reel/Frame 5560/0202 (the "Security Agreement").

WHEREAS, as evidenced by the Payoff Letter of even date herewith, the Borrowers have made payment to satisfy in full the obligations owed to the Lender by the Borrowers under the above recorded Security Agreement, and the Lender has agreed to terminate, release and discharge its security interest in the Borrowers' patents listed on Schedule B hereto and trademarks listed on Schedule C hereto (the "Intellectual Property").

All of Lender's security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created in Borrowers' Intellectual Property pursuant to the Security Agreement shall be automatically terminated, released and discharged.

If and to the extent that Lender has acquired any right, title or interest in or to any of the Borrowers' Intellectual Property, it hereby assigns and transfers such rights, title or interest to Borrowers, along with any goodwill in the Intellectual Property that the Lender may have acquired.
