**RELEASE AND TERMINATION
OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS, dated as of June 6, 2019 (this “Release”), is made by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Lenders (in such capacity, “Agent”), in favor of DIGITAL MAP PRODUCTS, INC., a Delaware corporation (“DMP”), and DMTI SPATIAL INC., an Ontario corporation (“DMTI”, and together with DMP, the “Pledgors”). All terms used but not defined herein shall have the meanings set forth (including by reference) in the Credit Agreement (as defined below).

WHEREAS, the Pledgors and the Agent are parties to that certain Revolving Credit, Term Loan, Security Agreement and Guaranty dated as of August 26, 2016 (as amended, modified and supplemented to date, the “Credit Agreement”), by and among SCP-DMP Acquisition, LLC, a Delaware limited liability company, SCP-DMP Merger Sub, LLC, DMP, 2583930 Ontario Inc., an Ontario corporation, DMTI, the lenders party thereto and the Agent;

WHEREAS, DMP and the Agent are party to that certain Trademark Security Agreement, dated as of August 26, 2016 (as amended, supplemented or otherwise modified from time to time, the “DMP Trademark Security Agreement”) pursuant to which DMP granted to the Agent a continuing security interest in the Trademark Collateral (as defined in the DMP Trademark Security Agreement), including the trademark and service mark registrations and applications listed on Schedule A hereto;

WHEREAS, DMTI and the Agent are party to that certain Trademark Security Agreement, dated as of July 11, 2017 (as amended, supplemented or otherwise modified from time to time, the “DMTI Trademark Security Agreement”, and together with the DMP Trademark Security Agreement, the “Trademark Security Agreements”) pursuant to which DMTI granted to the Agent a continuing security interest in the Trademark Collateral (as defined in the DMTI Trademark Security Agreement), including the trademark and service mark registrations and applications listed on Schedule A hereto;


WHEREAS, the Trademark Security Agreements were recorded in the records of the United States Patent and Trademark Office on August 29, 2016 at reel 5865, frame 0048 and on July 17, 2017 at reel 6106, frame 0769, respectively;

WHEREAS, pursuant to that certain Payoff Letter, dated as of June 6, 2019, by and between the Loan Parties and the Agent, the Pledgors have requested and the Agent has agreed to (a) release any and all security interests it may have in the Trademark Collateral and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest in the Trademark Collateral, (b) release and relinquish and discharge its liens on and security interest in the Trademark Collateral, and (c) re-assign, re-transfer and re-convey to the Pledgors any and all rights, title and interest it may have in, to or under the Trademark Collateral. The Agent agrees, or authorizes the Pledgors, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Pledgors to evidence the release and termination of the Agent’s security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
