**RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS** (this "Release"), dated as of May 31, 2019 (the "Effective Date"), from CoBank, ACB, as Administrative Agent (together with its successors, in such capacity, the "Agent"), to Eatel Directories, LLC (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Pledge Agreement or the Grant (in each case, as defined below), as applicable.

**WHEREAS**, the Grantor entered into that certain Pledge and Security Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), dated as of August 19, 2004, pursuant to which the Grantor granted to the Agent a security interest in certain intellectual property;

**WHEREAS**, in connection with the Security Agreement, the Grantor executed that certain Grant of Security Interest in Patents and Trademarks in favor of the Agent (the "Grant"), pursuant to which the Grantor reaffirmed its grant of a security interest in all of the Grantor's right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, including those set forth on Schedule A hereto (collectively, the "Collateral");

**WHEREAS**, the Grant was recorded in the United States Patent and Trademark Office on September 23, 2004 at Reel 002943 and Frame 0556; and

**WHEREAS**, the Agent now desires to terminate and release the entirety of its security interest in the Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, without representation, warranty or recourse of any kind, terminates, discharges, cancels and releases any and all liens and security interests it has against the Collateral.

The Agent shall take all further actions (including, the execution and delivery of any and all documents or other instruments), reasonably necessary to effect the release of the liens and security interests contemplated hereby, and at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release shall be construed in accordance with and governed by the laws of the State of Colorado.
