## **TERMINATION OF PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENTS**

This **TERMINATION OF PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENTS** (this "Termination"), dated as of June 3, 2019, is made by PNC Bank, National Association (f/k/a National City Bank of Pennsylvania), as administrative agent (in such capacity, the "Agent"), in favor of each of Vector Security, Inc., Vector Security Holdings, Inc., and The Jupiter Group, Inc. (each individually, an "Pledgor" and, collectively, the "Pledgors"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Security Agreement referred to below. Notwithstanding the foregoing, for the purposes of this Termination, "Patents, Trademarks and Copyrights" shall have the meaning assigned to such term in the IP Security Agreements and shall include, without limitation, those patents, patent applications, trademarks, trademark applications, copyrights and copyright applications listed on the exhibits attached hereto.

**WHEREAS**, pursuant to the (i) Security Agreement, dated as of June 24, 2011 (as amended, restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement"), among the Pledgors, the other Debtors (as defined therein) from time to time party thereto and the Agent, and (ii) each Patent, Trademark and Copyright Security Agreement or Ratification and Reaffirmation Agreement, as applicable, set forth on Schedule I hereto (as amended, restated, supplemented, waived or otherwise modified from time to time, collectively, the "IP Security Agreements" and each, an "IP Security Agreement"), executed by each Pledgor in favor of the Agent, each Pledgor pledged and granted to the Agent a security interest in and continuing lien on all of each Pledgor's right, title and interest in, to and under the Patents, Trademarks and Copyrights; and

**WHEREAS**, the Agent has agreed to terminate, release and discharge its security interest and lien on all of the Patents, Trademarks and Copyrights.

**NOW, THEREFORE**, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of each Pledgor secured by the Patents, Trademarks and Copyrights pursuant to the Security Agreement and the IP Security Agreements, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby terminates, releases and discharges all of its liens and security interests in all of each Pledgor's right, title and interest in, to and under the Patents, Trademarks and Copyrights, including all goodwill associated with the Patents, Trademarks and Copyrights, and hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Patents, Trademarks and Copyrights to each such Pledgor.

2. The Agent authorizes and requests that the United States Commissioner of Patents and Trademarks, the United States Register of Copyrights and any other applicable officer in any successor office or any similar office in any other country record this Termination.

3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE COMMONWEALTH OF PENNSYLVANIA, EXCLUDING ITS RULES RELATING TO CONFLICT OF LAWS.
