ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks is entered into as of this 8th day of April, 2019 (the "Effective Date"), by and between Justin Kaliszewski ("Petitioner" or "Assignee") and Mark Stefanowski ("Respondent" or "Assignor") (collectively, the "Parties"), pursuant to the terms and provisions of the Settlement Agreement, dated as of April 5, 2019, by and among Assignor and Assignee.

Recitals

A. WHEREAS, pursuant to the Settlement Agreement, Assignor has agreed to assign the following to Assignee: (i) U.S. Trademark Application Serial No. 85/736,697 for the mark OUTLAW YOGA; (ii) U.S. Registration No. 4,342,012, registered on May 28, 2013, for the trademark OUTLAW YOGA; and (iii) the Statement of Trademark Registration of an Individual Resident of Colorado, filed on June 20, 2012, the Statement of Trade Name of an Individual filed on April 6, 2013, and any subsequently filed renewals or corrections thereof (collectively, "Trademarks"). Assignee has agreed to accept such assignments.

B. NOW THEREFORE, pursuant to the Settlement Agreement and in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Assignment. Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Trademarks, together with all goodwill appurtenant thereto and the entire right, title and interest in and to any equity arising out of past, present or future infringement of the Trademark.

2. Settlement Agreement. This Assignment of Trademarks is subject in all respects to the terms and conditions of the Settlement Agreement, and nothing contained herein shall be deemed to supersede any of the covenants, agreements, representations or warranties of Assignor or Assignee contained in the Settlement Agreement.

3. Counterparts. This Assignment of Trademarks may be executed in several counterparts, each of which shall be deemed an original, but such counterparts shall together constitute but one and the same Assignment of Trademarks. This Assignment of Trademarks may be executed and delivered in counterpart signature pages executed and delivered via facsimile transmission, and any such counterpart executed and delivered via facsimile transmission shall be deemed an original for all intents and purposes.

4. Benefit. This Assignment of Trademark shall bind and inure to the benefit of the Parties hereto and their respective permitted successors and assigns.


