## RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of June 6, 2019, by **PACIFIC WESTERN BANK** (“Bank”) in favor of **ZENTILA, INC.**, a Delaware corporation (“Grantor”) with its principal place of business located at 13 Marshall St, Norwalk, CT 06854.

### Recitals

WHEREAS Grantor granted to Bank a security interest in certain Intellectual Property Collateral, including Copyrights, Trademarks and Patents, including without limitation the United States trademark application described on Exhibit A attached hereto, under that certain Intellectual Property Security Agreement dated as of April 3, 2018 (the “Security Agreement”), and recorded with the US Patent and Trademark Office on April 9, 2018 at Reel 6309 and Frame 0750.

WHEREAS Grantor has no outstanding obligations to Bank under the terms of the Security Agreement.

WHEREAS in consideration of the satisfaction of the obligations secured by the Security Agreement, Bank now desires to terminate and release the entirety of its security interest in the Intellectual Property Collateral.

### Agreement

NOW THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Intellectual Property Collateral, the sufficiency of which is hereby acknowledged, Bank hereby states as follows:


1. Bank hereby terminates and releases its liens and security interests in the Intellectual Property Collateral.
2. Bank reassigns to Grantor, without warranty or recourse, all right, title and interest of Bank in the Intellectual Property Collateral.
3. All terms used but not otherwise defined herein shall have the meanings ascribed to those terms in the Security Agreement and that certain Amended and Restated Loan and Security Agreement dated as of December 16, 2015 referenced therein.
