**PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is made this 5<sup>th</sup> day of June, 2019, by TEXAS CAPITAL BANK, NATIONAL ASSOCIATION, a national banking association ("Secured Party").

**WHEREAS**, reference is made to a certain Intellectual Property Security Agreement dated as of March 15, 2018, and recorded with the United States Patent and Trademark Office on March 21, 2018, at **Reel 6296 Frame 0752** (as amended, restated, amended and restated, supplemented and/or modified to date, the "IP Security Agreement"), by CLOVER TELECOM ASSET MANAGEMENT, LLC, a Delaware limited liability company ("Grantor"), in favor of Secured Party. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the IP Security Agreement.

**WHEREAS**, under the IP Security Agreement, Grantor granted to Secured Party a continuing security interest in all of the right, title and interest of Grantor in and to the Intellectual Property Collateral identified therein, including, but not limited to, the Trademark Licenses set forth on Schedule A attached hereto.


**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby (i) releases any and all liens on, and its security interest in and to the Trademark Licenses set forth on Schedule A attached hereto (the "Released Collateral") arising under the IP Security Agreement and (ii) authorizes the recordation of this Release by Grantor or its designee with the United States Patent and Trademark Office. The Secured Party hereby retains all of its liens and security interests in the Intellectual Property Collateral covered by the IP Security Agreement other than the Released Collateral.

This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.
