## Exhibit A

The Articles of Incorporation are hereby amended by amending and restating Paragraph 1 in full. From the date set forth on this Amendment, Paragraph 1 shall read:

1. The name of the Corporation shall be **Wayne Bailey, Inc.**

The Articles of Incorporation are hereby amended by amending and restating Paragraph 4 in full to eliminate the preferred stock created in the Amendment dated November 26, 2008 and filed at the Secretary of State from the date set forth on this Amendment, Paragraph 4 shall read in its entirety:

4. The aggregate number of shares which the corporation shall have authority to issue is 100,000 all of one class, designated as common stock.
