**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “Assignment”), effective as of May 2, 2019 (the “Effective Date”), is by and between Advance Local Media LLC, a New York limited liability company (“Assignor”), and Capital City Press, LLC, a Louisiana limited liability company (“Assignee”). Capitalized terms used herein but not otherwise defined herein shall have the meanings set forth in the Purchase Agreement (defined below).

WHEREAS, Assignee and Assignor entered into that certain Asset Purchase Agreement, dated as of May 2, 2019 (as amended, modified or supplemented from time to time, the “Purchase Agreement”);

WHEREAS, Assignor is the (a) owner of each of the trademarks, trademark registrations and trademark applications (including any and all goodwill symbolized by any of the foregoing) set forth on Schedule A hereto (the “Trademarks”); (b) owner of each of the copyrights, copyright registrations, copyright applications for registration set forth on Schedule B hereto (the “Copyrights”); and (c) registrant of record and owner of each of the Internet domain names (including any and all goodwill symbolized thereby) set forth on Schedule C hereto and the domain name registrations therefor (the “Domain Names”); (the Trademarks, Copyrights, and Domain Names, collectively, the “Assigned Intellectual Property”);

WHEREAS, upon the terms and subject to the conditions of the Purchase Agreement, Assignee agreed to cause Assignor to transfer to Assignee sole ownership of all right, title and interest in and to the Assigned Intellectual Property, and to execute this Assignment; and

WHEREAS, the execution and delivery of this Assignment is a condition to Closing.

NOW, THEREFORE, for good and valuable consideration, including the consideration reflected in the Purchase Agreement, the sufficiency and receipt of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Upon the terms and subject to the conditions of the Purchase Agreement, effective upon the date hereof, Assignor hereby sells, assigns, transfers, and conveys to Assignee, and Assignee hereby accepts the sale, assignment, transfer and conveyance of, all right, title and interest in and to the Assigned Intellectual Property, including all rights therein provided by international conventions and treaties; all royalties, fees, payments and proceeds due with respect thereto; all rights of priority and renewals; and all rights to sue and recover damages for past, present and future infringement, dilution, misappropriation, unlawful imitation or other violation thereof or conflict therewith.

2. Within five (5) days following the Closing, Assignor shall, per the policies and rules of the applicable Internet domain name registrar for each Domain Name (the

“Registering Authority”), unlock each Domain Name and provide Assignee with the necessary authorization codes required by the Registering Authority to transfer the Domain Names from Assignor to Assignee, confirm the digital transfer requests for the transfer of the Domain Names from Assignor to Assignee with the Registering Authority, and take any further actions, if necessary, in accordance with the policies and rules of the Registering Authority as required to transfer such Domain Names to Assignee on an expedited basis.

3. Upon reasonable request by Assignee, the applicable Assignor will execute additional documents and take other actions as may be necessary or desirable to record or memorialize the assignments of the Assigned Intellectual Property, and to vest in Assignee such right, title and interest in and to the Assigned Intellectual Property as assigned and transferred to Assignee hereunder.

4. Assignor hereby authorizes and requests the officials of the United States Patent and Trademark Office and the United States Copyright Office, and the corresponding entities or agencies in any applicable foreign jurisdiction, to record Assignee as assignee and owner of the entire right, title and interest in, to and under the Assigned Intellectual Property.

5. Assignor hereby authorizes and requests the officials of the Louisiana Secretary of State to record Assignee as assignee and owner of the entire right, title and interest in, to and under the applicable Assigned Intellectual Property.

6. No waiver, modification or change of any of the provisions of this Assignment shall be valid unless in writing and signed by the party against whom such claimed waiver, modification or change is sought to be enforced.

7. This Assignment may be executed and delivered (including by facsimile or other means of electronic transmission, such as by electronic mail in “pdf” form) in counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement.
