The undersigned natural person, being the President of the captioned entity, and pursuant to the terms of Utah's Revised Uniform Limited Liability Company Act (hereinafter referred to as the "Act"), does hereby state as follows:

ARTICLE I

NAME AND ENTITY TYPE PRIOR TO FILING OF ARTICLES OF CONVERSION

Immediately prior to the filing of these Articles of Conversion: (i) the name of the subject entity was ONCOR, INC., and (ii) the entity was a corporation.

ARTICLE II

JURISDICTION WHEN FIRST FORMED

ONCOR, INC. was first formed under the laws of the state of Utah on February 2, 1977. The entity has not changed its jurisdiction since its formation.

ARTICLE III

NAME AND ENTITY TYPE SET FORTH IN ARTICLES OF ORGANIZATION

The name of the company set forth in its Articles of Organization filed in accordance with Subsection 48-3a-1042 of the Act is ONCOR, LLC and the entity type is a limited liability company.

CONVERSION OF SHARES

BIRD. The 7,900 shares held by MARK DENNIS JENSEN are being exchanged for 7,900 shares in ONCOR HOLDINGS, INC., and the 2,100 shares held by KEITH T. BIRD are being exchanged for 2,100 shares in ONCOR HOLDINGS, INC. Following this exchange, ONCOR HOLDINGS, INC. will own 100% of the membership interests in ONCOR, LLC.

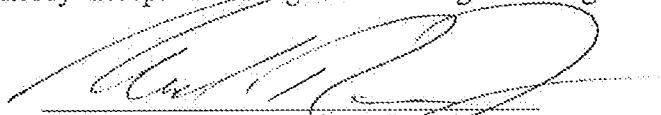
