SHORT FORM TRADEMARK ASSIGNMENT

This SHORT FORM TRADEMARK ASSIGNMENT ("Short Form Assignment"), effective as of April 16, 2019 (the "Effective Date"), is made by STARBREEZE AB (Publ), a Publikt Aktiebolag or public limited liability company, organized under the laws of Sweden ("Assignor"), in favor of NEW STARBREEZE PUBLISHING AB, an Aktiebolag or private limited company, organized under the laws of Sweden ("Assignee"), the purchaser of certain assets of Assignor pursuant to that certain "Överlåtelseavtal" Agreement, (translated into the English language as "Sale and Purchase Agreement") between Assignor and Assignee dated and made effective as of April 16, 2019 (the "Agreement").

WHEREAS, under the terms of the Agreement, Assignor has conveyed, transferred, and assigned to Assignee, among other assets, certain intellectual property of Assignor, and has agreed to execute and deliver this Short Form Assignment for recordation purposes;

WHEREAS, this Short Form Assignment is subject to all the terms and conditions of the Agreement, and in the event of a conflict between this Short Form Assignment and the Agreement, the terms of the Agreement shall control;

NOW THEREFORE, for good and valuable consideration paid by Assignee to the Assignor, and the mutual covenants contained herein, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree that pursuant to the Agreement, Assignor hereby irrevocably assigns, grants, transfers and conveys to Assignee all of Assignor's right, title and interest of every kind and nature throughout the world in perpetuity in and to all of the trademarks set forth on Schedule "A" attached hereto and incorporated herein by this reference (the "Trademarks").

Assignor's assignment, grant, transfer and conveyance of its rights in and to the Trademarks is on a worldwide basis, which shall include, without limitation, all rights that may now or hereafter be vested anywhere in the world, together with all United States' and non-U.S. federal, state and common law registrations, applications for registration and renewals and extensions thereof; all goodwill associated therewith; and all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all such registrations, all renewals and/or extensions; to sue for all past, present or future infringements or other violations of any rights whatsoever in the Trademarks; and to settle and retain proceeds from any such actions), to be held and enjoyed by the Assignee, its successors and assigns, to the same extent that such would have been held and enjoyed by Assignor had such assignment not been made.

The transfer of the Trademarks accompanies, pursuant to the Agreement, the transfer of that portion of Assignor's business to which the Trademarks pertain as required by Section 10 of the Trademark Act (15 U.S.C. § 1060).
