This RELEASE OF SECURITY INTEREST (the "Release") effective as of April 16, 2019 is granted by The Director of the Ohio Development Services Agency, (the "Director"), an agency of the State of Ohio, in favor of Frameri, Inc., a Delaware corporation (the "Grantor") and its successors, legal representatives and assigns.

WHEREAS, pursuant to that certain Loan Agreement dated as of August 3, 2015 (the "Loan Agreement") between the Grantor and the Director, the Grantor executed and delivered to the Director that certain Intellectual Property Security Agreement by and between the Grantor and the Director dated as of August 3, 2015 (the "IP Security Agreement");

WHEREAS, pursuant to the IP Security Agreement, the Grantor pledged and granted to the Director, for the benefit of the Director, a security interest in and to all of the right, title and interest of such Grantor in, to and under the Secured Properties (as defined below);

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5595, Frame 0237 on August 6, 2015 at Docket Number OH5005-FI0040; and

WHEREAS, the Grantor has requested that the Director enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor and its successors, assigns and legal representatives of any and all right, title and interest the Director may have in the collateral pursuant to the IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Director hereby states as follows:

1. Release of Security Interest. The Director, on behalf of the Director, and the agency's successors, legal representatives and assigns, hereby terminates the IP Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the IP Security Agreement in any and all right, title and interest of the Grantor, and reassigns to the Grantor and its successors, legal representatives and assigns, any and all right, title and interest that it may have, in, to and under the following (collectively, the "Secured Properties"):

- a. Any and all trademarks, trademark applications and other trademark rights together with any other governmental authority-issued indicia of trademark ownership, including the trademarks and trademark applications listed in Schedule A hereto, and all reissues, renewals, and extensions thereto;
- b. All rights of any kind whatsoever of such Grantor accruing under any of the Secured Properties provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

- c. Any and all license and other agreements in which such Grantor has granted or is granted a license or other right under any of the Secured Properties;
- d. Any and all claims and causes of action, with respect to any of the Secured Properties, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Further Assurances. The Director agrees to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.


3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Ohio, without giving effect to any choice or conflict of law provision or rule (whether of the State of Ohio or any other jurisdiction).
