TRADEMARK SECURITY RELEASE AGREEMENT

This TRADEMARK SECURITY RELEASE AGREEMENT, dated as of May 1, 2019 (the “*Trademark Security Release*”), is executed and delivered by GOLDMAN SACHS BANK USA, (the “*Collateral Agent*”) in favor of the parties listed in Schedule A (each a “*Grantor*” and collectively, the “*Grantors*”).

WHEREAS, the Grantors and the Collateral Agent have entered into a Credit Agreement dated July 29, 2016 (as may be amended, restated, supplemented or otherwise modified from time to time, the “*Credit Agreement*”);

WHEREAS, the Grantors and the Collateral Agent have entered into a Security Agreement dated July 29, 2016 (as may be amended, restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”);

WHEREAS, pursuant to the Security Agreement, each of the Grantors granted to the Collateral Agent a security interest in the trademark registration set forth on Schedule B attached hereto (the “*Trademark Collateral*”);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on August 11, 2016 at Reel 5853/Frame 0565;

WHEREAS, in accordance with that certain Payoff Letter dated May 1, 2019 and sent by the Collateral Agent (the “*Release*”), the obligations secured by the Trademark Collateral have been repaid or otherwise satisfied to the extent set forth in such Release; and

WHEREAS, the Collateral Agent therefore desires to release its security interest in and to the Grantors’ right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Collateral Agent does hereby release, without recourse, representation or warranty of any kind, all of the Collateral Agent’s right, title and interest in and to each of the Grantor’s right, title and interest in and to the Trademark Collateral granted pursuant to the Security Agreement.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Trademarks record this Trademark Security Release.

SECTION 3. Execution in Counterparts. This Trademark Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Trademark Security Release by facsimile will be as effective as delivery of a manually executed counterpart of this Trademark Security Release.

SECTION 4. Governing Law. This Trademark Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
