**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of June 13, 2019 (“Release”), is made by The Huntington National Bank, with an address of 200 Public Square, Cleveland, Ohio 44114 (the “Secured Party”) in favor of FPG Services, LLC (the “Grantor”).

WHEREAS, pursuant to that certain Credit and Security Agreement, dated as of June 1, 2015 (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among the Grantor, FPG Labs, LLC and the Secured Party, and the Supplement to Intellectual Property Security Agreement, dated as of December 3, 2018 (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), by the Grantor in favor of the Secured Party, the Grantor granted to the Secured Party, a lien on and security interest in and to all of its right, title and interest in, to, and under the US Registered Intellectual Property listed on Schedule A attached hereto (the “Trademark Collateral”); and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on January 3, 2019 at reel 006516 frame 0565.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party and the Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized definitional terms used herein but not otherwise defined herein have the meanings given to them in the Credit Agreement or the Trademark Security Agreement as applicable.

SECTION 2. Termination and Release. The Secured Party, without representation, warranty, or recourse, hereby:


- (a) terminates, cancels, discharges, and releases the lien on and security interest in and to all of the Grantor’s right, title, and interest in, to, and under all of the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and
- (b) authorizes the recordation of this Release with the USPTO at the Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with New York law, without regard to principles of conflicts of laws that would result in the application of the law of any other jurisdiction.
