TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made as of May 10, 2019, Alfred Angelo Newco, Inc., the successor-in-interest to Alfred Angelo, Inc. (Assignor), in favor of Gangnam Inc., located at Palm Grove House, P.O. Box 438, Road Town, Tortola, British Virgin Islands ("Assignee").

RECITALS

WHEREAS, Assignor is the Chapter 7 Trustee duly appointed in the Chapter 7 bankruptcy matter which cases were filed on July 14, 2017, Case No. 17-18871 ("Bankruptcy"). The Bankruptcy cases have been jointly administered (all cases for all Debtors will be referred to as "Debtors Cases") pursuant to an Order of this Court dated July 19, 2017 with lead case #17-18864. The Debtors in Debtors Cases include: Alfred Angelo Newco, Inc. (17-18900), the current owner of the Marks as hereinafter defined.

WHEREAS, Assignor is the sole and exclusive owner of the entire right, title and interest in, to and under the trademark registration and application listed in Appendix A attached hereto, including any common law trademark rights therefor (the "Marks"); and

WHEREAS, Assignor and Assignee have entered into an Asset Purchase Agreement dated April 10, 2019 (the "Agreement"), under which Assignor agreed to assign to Assignee all of Assignor's right, title and interest in and to the Marks, together with the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, convey, assign, transfer and set over to Assignee, Assignor's entire right, title and interest, as of May 10, 2019, in and to the Marks, together with the goodwill associated with or symbolized by the Marks, for the United States and for all foreign countries, including but not limited to all rights to apply for, file, register, maintain, renew or extend the Marks and to transfer same and grant licenses and other rights with respect thereto that are or may be secured under the laws of the United States or foreign countries now or hereafter in effect and including the subject matter of all claims which may be obtained therefrom for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all income, royalties or payments due or payable as of the effective date of this Assignment or thereafter, including but not limited to all claims, causes of action and enforcement rights of any kind for damages by reason of past, present or future infringement or other unauthorized use, misappropriation or violation of the Marks, with the right to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

The Assignor hereby authorizes any competent authority in the United States including the United States Patent and Trademark Office or any foreign equivalent thereto to record this assignment.

This Assignment is deemed to be executed and delivered within the State of Florida, and it is the intention of the parties that it shall be construed, interpreted and applied in accordance with the laws of the State of Florida without regard to its conflicts of law principles.

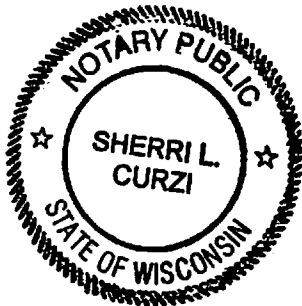
