**INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE**

**RELEASE OF SECURITY AGREEMENT**, dated as of June 11, 2019, by Rosenthal & Rosenthal, Inc. (the "Lender"), for the benefit of The J. Peterman Company LLC (the "Company"), in connection with the Financing Agreement by and among Company and Lender, dated October 26, 2018 (the "Financing Agreement"). Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Financing Agreement.

**WHEREAS**, the Lender and the Company entered into that certain Intellectual Property Security Agreement, dated as of November 15, 2017 (as amended, modified or supplemented from time to time, the "Intellectual Property Security Agreement"), which was recorded with the United States Patent and Trademark Office at Reel 6212, Frame 0547 on November 22, 2017 and;

**WHEREAS**, pursuant to the Intellectual Property Security Agreement, the Company pledged to the Lender a lien on, and security interest in, all of the Collateral as collateral security for the full, prompt and complete payment and performance of the Obligations.

In connection with the termination of all obligations and liabilities of the Company under the Financing Agreement, as of November 20, 2017, the Lender has agreed (i) to terminate and release all its security interest and all its right, title and interest in, to and under the Collateral (as defined in the Financing Agreement), including, without limitation, those items identified on Exhibits A attached hereto, all reissues, continuations or continuations-in-part of the foregoing and all proceeds of the foregoing, including, without limitation, any claim by the Lender against third parties for past, present or future infringement of any Collateral (collectively, the "Released Collateral"), each of such Released Collateral being owned by and registered in the name of the Company and with respect to which a security interest therein was granted to the Lender pursuant to the Intellectual Property Security Agreements and (ii) to assign and transfer to Company all deeds, assignments and other instruments as may be necessary or proper to reassign, reconvey and re-vest in Company the entire right, title and interest in the Released Collateral, as herein provided;

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby releases the Company from the Intellectual Property Security Agreement and assigns and transfers to Company, without representation, warranty or recourse, all of the Lender's right, title and interest in and to each of the Released Collateral in which Company granted a security interest to the Lender pursuant to the Intellectual Property Security Agreements, effective as of the date set forth above.
