TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of June 14, 2019, by ARES CAPITAL CORPORATION (successor to Pacific Western Bank ("Pacific Western")), in its capacity as collateral agent (the "Collateral Agent").

WITNESSETH:

WHEREAS, WOLFPACK IP CO., a Delaware corporation (the "Pledgor") and Pacific Western entered into that certain Security Agreement dated as of July 5, 2016 (as amended, amended and restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Pledgor and Pacific Western entered into that certain Trademark Security Agreement, dated as of October 16, 2017 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office ("USPTO") on October 16, 2017 at Reel/Frame No. 6183/0099, pursuant to which the Pledgor pledged and granted to Pacific Western a security interest in and to all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to the Assignment of Intellectual Property Security Agreement, dated as of May 18, 2018 (the "Assignment"), and recorded with the USPTO on May 18, 2018 at Reel/Frame No. 6387/0430, Pacific Western assigned and transferred to Ares Capital Corporation and its successors and assigns, all of its rights, title and interest in and to the Trademark Security Agreement; and


WHEREAS, the Pledgor has requested that the Collateral Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to the Pledgor.

NOW THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement, the Trademark Security Agreement, and the Assignment.
