## RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release and Assignment") is executed to be effective as of June 12, 2019 (the "Effective Date"), by Simmons Bank, an Arkansas state bank [successor-in-interest by merger with Southwest Bank, a Texas state bank], having a business location at 3641 Matlock Road, Arlington, Texas 76015 ("Simmons Bank").

Rhythm Band Instruments, LLC, a Texas limited liability company, having a business address of P.O. Box 165117, Fort Worth, Texas 76161 ("RBI"), and Simmons Bank's predecessor-in-interest, Southwest Bank, entered into that certain Trademark Security Agreement dated June 3, 2016 ("Trademark Security Agreement") to secure certain amounts owed by RBI. Pursuant to the Trademark Security Agreement, RBI granted to Southwest Bank, a security interest (which security interest is now held by Simmons Bank, as successor-in-interest by merger with Southwest Bank) in certain intellectual property ("Intellectual Property") including, without limitation, the following:

- a) U.S. Trademark Registration No. 2200973, for "BOOMWHACKERS";
- b) U.S. Trademark Registration No. 4828381, for the trademark more particularly described therein;
- c) U.S. Trademark Registration No. 4328280, for "BAMBOOM";
- d) U.S. Trademark Registration No. 3104008, for "ZOO RHYTHMS";
- e) U.S. Trademark Registration No. 1946782, for "KIDSPLAY";
- f) U.S. Trademark Registration No. 1788859, for "RBI";
- g) U.S. Trademark Registration No. 1966433, for "CANTO";
- h) U.S. Trademark Registration No. 1733289, for "KIDSPLAY";
- i) Common law trademark rights applicable to the foregoing trademarks;
- j) The entire goodwill associated with such trademarks; and
- k) Proceeds therefrom.

Simmons Bank acknowledges that all amounts owed which were secured by the Trademark Security Agreement have been paid in full and Simmons Bank is fully satisfied. Simmons Bank, as successor-in-interest by merger with Southwest Bank, hereby completely releases and forever discharges RBI, its successors and assigns, from any and all liens and claims arising from the Trademark Security Agreement and hereby releases all of the Intellectual Property referred to in the Trademark Security Agreement.
