**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of June 17, 2019 by **WELLS FARGO BANK, N.A.**, a United States national banking association (in such capacity, together with its successors and assigns, “Secured Party”) in favor of **CNG HOLDINGS, INC.**, an Ohio corporation with an address at 7755 Montgomery Rd., Suite 400, Cincinnati, Ohio 45236 (“Grantor”).

W I T N E S S E T H:

WHEREAS, Grantor entered into a certain trademark security agreement dated May 9, 2012 (the “Trademark Security Agreement”) with Secured Party, notice of which was recorded on May 14, 2012 at the United States Patent and Trademark Office at Reel 4779, Frame 0366.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Secured Party, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Secured Party, in all of its right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Secured Party has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Secured Party, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, including all of the goodwill of such Grantor’s business symbolized by the Trademarks and associated therewith, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest and any other liens. The Secured Party further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
