AND WHEREAS, Samsung Electronics Co., Ltd., a Korean Corporation, with its principal place of business at 129, Samsung-ro, Yeongtong-gu Suwon-si, Gyeonggi-do, Korea (hereinafter called the ASSIGNEE) is the successor to that portion of the business for GALAXY ACTIVE PRO to which ASSIGNOR owns, and said business is ongoing and existing and ASSIGNEE is desirous of acquiring the entire right, title and interest in and to the said mark and the registration thereof;

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE its portion of the entire right, title and interest in perpetuity in and to said mark, including any common law rights and other rights of use, together with the goodwill of the business symbolized by said mark, the same to be held and enjoyed by the ASSIGNEE, its successors and assigns to the same extent that such would have been held and enjoyed by ASSIGNOR absent this Assignment. ASSIGNOR hereby covenants and agrees to provide any further necessary and appropriate documentation and do all further acts reasonably requested by ASSIGNEE in this regard to confirm and perfect title in and to the entirety of said mark in ASSIGNEE, its successors, assigns, or other legal representatives.

The Commissioner of Patents and Trademarks is requested to issue the Certificate of Registration to the said ASSIGNEE.
