TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Assignment"), is made and entered into this 18th day of December, 2009 (the "Effective Date") between Tyco Electronics Services GmbH, a company organized under the laws of Switzerland, with a place of business at Rheinstrasse 20, CH-8200 Schaffhausen, Switzerland ("Assignor"), and Prefomed Line Products Company, an Ohio corporation with a place of business at 660 Beta Drive, Mayfield Village, Ohio ("Assignee").

WHEREAS, Tyco Electronics Group S.A., a company organized under the laws of Luxembourg, and Assignee are parties to that certain Stock and Asset Purchase Agreement dated as of October 22, 2009 (the "Purchase Agreement"), pursuant to which, among other things, Tyco Electronics Group S.A. agreed to cause Assignor to sell, convey, assign and transfer to Assignee, and Assignee agreed to purchase, acquire and accept from Assignor, all of Assignor's right, title and interest in certain assets, properties and rights, including certain trademarks and certain patents and patent applications.

WHEREAS, Assignee desires to purchase or acquire all of Assignor's right, title and interest in and to such trademarks.

WHEREAS, Assignee is the Assignor's successor with respect to the Business (as defined below), to which Business the trademarks assigned hereunder pertain, and the Business is ongoing and existing;

WHEREAS, the Business is defined as Assignor's Dulmison business which designs, manufactures and distributes medium-voltage and high-voltage overhead line fittings, including vibration dampening and control products and heliformed products for use by electrical utilities and communication and cable infrastructure provider.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties, intending to be legally bound, do covenant and agree as follows:

1. Assignment of Trademarks. Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee and Assignee accepts all right, title and interest of Assignor in and to:
 - (a) all trademarks used exclusively in the Business, including the trademarks set forth in Annex A hereto (the "Assigned Trademarks");
 - (b) the goodwill associated with the Assigned Trademarks and goodwill of the business connected with the use thereof and symbolized thereby;
 - (c) all income, royalties, damages, and payments due or payable to Assignor with respect to the Assigned Trademarks, including without limitation unpaid damages and payments for past, present, and future infringements of any Assigned Trademark, excluding any and all liabilities, claims, demands, rights and entitlements against Assignor or affiliates of Assignor arising during or out of their ownership and/or operation of the Business, and
 - (c) any registrations and applications for the Assigned Trademarks, and all claims, if any, which may have arisen thereunder prior to the Effective Date, and the right

to sue and to recover for damages, profits, payments and all other remedies for past, present and future infringements of any of the Assigned Trademarks, including the right to fully and entirely replace Assignor in all related matters.

3. Successors. This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of Assignor and Assignee.
4. Counterparts. This Assignment may be executed in counterparts as provided in Section 10.11 of the Purchase Agreement.

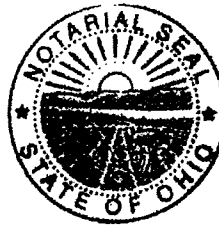
