RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of June 13, 2019 (the "Effective Date") in favor of BUDDERFLY, INC., a Delaware corporation ("Debtor"), by ENHANCED CAPITAL CONNECTICUT FUND V, LLC ("Lender").

WHEREAS, Debtor and Lender entered into that certain Loan and Security Agreement by and between Debtor, Al Subbloie and Lender dated as of September 29, 2017 (the "Loan Agreement");

WHEREAS, pursuant to the Loan Agreement, Debtor granted to Lender a security interest in all of its right, title and interest in, to and under certain intellectual property and entered into that certain Trademark Security Agreement (the "Trademark Security Agreement") for the purpose of recording such security interest with respect to the trademarks and applications therefor of Debtor, including those the trademark set forth on Schedule A hereto (collectively, the "Intellectual Property Collateral"), with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 3, 2017, at Reel 6171, Frame 0046; and

WHEREAS, Lender has agreed to release its liens on the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (a) terminates the Trademark Security Agreement, (b) terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral, and (c) re-assigns to Debtor any right, title and interest it may have in, to and under the Intellectual Property Collateral to Debtor.

This Release shall be governed by and construed in accordance with the laws of the State of Connecticut.
