## **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of June 3, 2019 (this "**Release**"), is made by VENTURE LENDING & LEASING VIII, INC. ("**VLL8**") and VENTURE LENDING & LEASING IX, INC. ("**VLL9**", and together with VLL8, the "**Secured Party**"), both Maryland corporations with an address at 104 La Mesa Drive, Ste. 102, Portola Valley, California 94028, in favor of ZOOMDATA, INC., a Delaware corporation with an address at 401 E 3<sup>rd</sup> Avenue, San Mateo, California 94401 ("**Grantor**") (Security Party and Grantor, each a "**Party**" and collectively the "**Parties**"), as follows:

### **WITNESETH**

WHEREAS, pursuant to that certain Security Agreement, dated as of December 4, 2018, between Secured Party, as lender, and Grantor, as borrower (as amended, restated, supplemented, or otherwise modified from time to time), the Parties have executed that certain Intellectual Property Security Agreement, dated December 4, 2018 ("**IP Security Agreement**"), which was recorded with the United States Patent and Trademark Office ("**USPTO**"); and

WHEREAS, pursuant to the Payoff Letter dated June 3, 2019 ("**Payoff Letter**"), Secured Party has released, in favor of Grantor, all of its security interest in the Collateral, including those Copyrights, Patents, Trademarks, as each of these foregoing terms are defined in the IP Security Agreement, including those Patents and Trademarks of Grantor as listed on **Schedule A** attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged and as set forth in the Payoff Letter, the Parties hereto agree, confirm, and acknowledge as follows:

Secured Party hereby agrees to release and re-convey to Grantor, without recourse, and does hereby release and re-convey to Grantor, any and all of Secured Party's right, title and interest in and to its security interest in the Collateral, including those Patents and Trademarks of Grantor listed on **Schedule A** attached hereto.


Secured Party confirms that (i) this Release may be filed with the USPTO and in any other applicable government office as desired by Grantor, and (ii) it will take any other reasonable steps to assist Grantor to record this Release as desired, including executing any other documents to effectuate the intent of this Release.

The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the terms and conditions of the Payoff Letter and this Release is expressly subject thereto. Capitalized terms used but not defined herein shall have the meanings given to them in the IP Security Agreement.




