TRADEMARK ASSIGNMENT

This **Trademark Assignment Agreement** (the "Trademark Assignment") is made and entered into as of June 3, 2019 (the "Effective Date") by and between Barracuda Networks, Inc., a Delaware corporation (the "Assignor") and airSlate, Inc., (formerly "PDFfiller, Inc."), a Delaware corporation (the "Assignee"). Assignee and Assignor are sometimes referred to herein individually as a "Party" and collectively as the "Parties".

1. As of the Effective Date, Assignor hereby assigns, transfers, sells and conveys to Assignee all of Assignor's right, title, and interest in and to the Assigned Trademark, together with all goodwill associated with the Assigned Trademark, and the right to all future damages and claims for any past, present or future infringement of the Assigned Trademark, or other violation or unauthorized use of the Assigned Trademark, with the right to sue for, and collect the same.
2. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the corresponding empowered officials of all other governments to issue or transfer the Assigned Trademark to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.
3. Each provision of this Trademark Assignment will be interpreted in such a manner as to be effective and valid under applicable law, but if any term or other provision of this Trademark Assignment is held to be invalid, illegal or unenforceable under applicable law, all other provisions of this Trademark Assignment shall remain in full force and effect.
4. This Trademark Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. This Trademark Assignment may not be amended except by an instrument in writing signed by each of the Parties hereto.
5. This Trademark Assignment shall be governed by and construed in accordance with the internal laws (and not the law of conflicts) of the State of Delaware.
