Ledbetter & Harp, LLC (a Tennessee limited liability company) is a limited liability company organized and existing under the laws of the State of Tennessee, having been formed by Articles of Organization filed on September 12, 2014.
2. An Agreement of Merger (attached hereto and incorporated herein) was approved and executed by the sole member-manager of Ledbetter & Harp LLC (a California limited liability company) and the sole member-manager of Ledbetter & Harp, LLC (a Tennessee limited liability company) on September 16, 2014.
3. The surviving constituent party to the Agreement of Merger is Ledbetter & Harp, LLC.
4. The surviving entity has adopted the Operating Agreement of the disappearing entity in full.


5. The merger is effective upon the filing of this Certificate of Merger along with the attached Agreement of Merger.

AGREEMENT OF MERGER OF LIMITED LIABILITY COMPANIES

This Agreement of Merger dated September 16, 2014, between Ledbetter & Harp LLC (a California limited liability company) (hereinafter "L&H CA") and Ledbetter & Harp, LLC. (a Tennessee limited liability company) (hereinafter "L&H TN").

L&H CA is a limited liability company organized and existing under the laws of the State of California, having been formed by Articles of Organization filed on February 24, 2003, with an Operating Agreement for Member-Managed Limited Liability Company effective that same date, with an initial membership of two members owning 50% of the Ownership Units each. The Operating Agreement has been amended on June 6, 2003, April 29, 2011, and June 21, 2014. The current membership is a single member, Jeff Ledbetter, owning 100% of the Ownership Units.

L&H TN is a limited liability company organized and existing under the laws of the State of Tennessee, having been formed by Articles of Organization filed on September 12, 2014, as a single-member limited liability company with Jeff Ledbetter owning 100% of the Ownership Units.

The single member-manager of L&H CA and L&H TN deems it advisable and in the best interests of the limited liability companies to be merged into L&H TN, and the companies, respectively, desire that they so merge under and pursuant to the laws of California and Tennessee.

Now, therefore, in consideration of the premises and mutual covenants set forth herein, and for the purpose of prescribing the terms of said merger, the parties agree as follows:

1. Merger: The merger shall be effective upon the filing of all documents required by Tennessee and California law, at which time, only one entity shall survive (the "Surviving LLC").
2. Name and purposes of Surviving LLC. The Surviving LLC shall be named Ledbetter & Harp, LLC, and shall operate to conduct all lawful business.
3. Operating Agreement. At the effective date of the merger, the Operating Agreement of L&H CA shall become the Operating Agreement of the Surviving LLC without amendment.
4. Members and Managers. At the effective date of the merger, the single Member-Manager of L&H CA shall become the single Member-Manager of L&H TN.
5. Conversion of Ownership Units. At the effective date of the merger, each single Ownership Unit of L&H CA shall be converted into a single Ownership Unit of L&H TN without a change in ownership of those Ownership Units.


Pursuant to California Corporations Code Section 17710.17(f)(1), (2) and (3), the Surviving Entity agrees as follows:

1. The Surviving Entity may be served in the State of California in a proceeding for the enforcement of an obligation of the Disappearing Entity and in a proceeding to enforce the rights of any holder of a dissenting interest or dissenting shares in the Disappearing Entity;
